This has been a very busy month. During the month of January I worked on the Presidents report and submitted it to the state. During this process I was truly impressed with all that the women of this club did during the past year. Every month the committees reported on their activities but when it is all put together it just blew me away. I thought I would share a little of what happened this past year. We had over 36 Homelife projects. So of these projects were monetary donations and some were donation of items and some were donations of time. I would like to touch on items that were donated and time donated. We donated in kind donations of about \$48,000 and gave 64 hours in this category. We donated 95 quilts, 11 twin blankets, 15 pillows, 3 rubber mats and 2 sheet sets to the Comea House, we also donated \$5000 for feeding the homeless and gave them a new industrial dishwasher. We personally were involved in the Climb Wyoming Graduation by pouring punch and serving the cake and doing the clean up, \$500.00 was also donated for 10 graduates to have a nice Thanksgiving. We also had a couple of committees serve meals at the Circles program, this was well received by this group.

This is just a small snapshot of all that our club members did this past year. I am proud to be a member of this club and to rub shoulders with so many great and wonderful women.

I want to remind you that we will be discussing the

I commend the group of women who took on this project, it was a lot time spent doing this, I appreciate all the time they put in on this project.





The WCLC Special Projects Committee will be asking WCLC members for donations for the Cheyenne Animal Shelter at our Feb. 2015 General Membership Meeting.


Please bring any of the following items if you would like in support of the Cheyenne Animal Shelter:
