## General Federation of Women's Clubs (GFWC)

**The Year, 1868:** Professional journalist Jane Cunningham Croly was denied entrance to an all-male press club event and responds by organizing a woman's club. Jennie June, as she was known, names the club Sorosis, a Greek word meaning "an aggregation; a sweet flavor of many fruits."

The Year, 1889: The Sorosis Club of New York City convenes 61 women's clubs from around the country to organize a federation. Sorosis President Ella Dietz Clymer closed her address at the March conference with the words, "We look for unity, but unity in diversity."

**The Year, 1890:** On April 24, at the Scottish Rite Hall in New York City, 63 delegates from 17 states ratify the constitution of the General Federation of Women's Clubs. Clubwoman Julia Ward Howe, poet and social activist who wrote the lyrics of "The Battle Hymn of the Republic," was one of the constitution's authors.

**The Year, 1891:** The first GFWC council meets in West Orange, New Jersey. After a luncheon hosted by his wife, Mina, inventor Thomas A. Edison invited GFWC delegates to his lab for a demonstration of the kinetoscope, an early motion picture projector.

**The Year, 1904:** Clubwoman Alice Lakey (New Jersey) initiated a letter-writing drive to advocate for pure food legislation. Taking up Lakey's passion, GFWC promoted a nationwide awareness campaign that lead to the passage of the Pure Food and Drug Act in 1906. The Pure Food and Drug Act of 1906 was the first of a series of significant consumer protection laws enacted by the federal government in the 20th century and led to the creation of the Food and Drug Administration.

Purchases were approved in January for batting for Quilts for Valor, and for fleece to make blankets for children whose parents are deploying.

In February, Mary Lee Dixon purchased 46 yards of fabric-red, white, and blue (half of a football field!!!). Also bought were six rolls of sewing thread, three large rolls of quilting thread, and iron-on fabric for the labels for each quilt. The Quilted Corner owner, Brenda Salverson, gave us a 20% discount, as well as using our tax exempt status. Therefore, Mary Lee was able to receive \$630 in goods for \$500. Quite a buy!! So, please, next time you are in The Quilted Corner, thank Brenda for her generosity.

Sue Tardif had an equally impressive shopping spree for fleece and other materials for blankets. The project was formally known as Project Linus, which is now defunct. The new project planners are making blankets for Laramie County children whose parent(s) are deploying. Sue was able to buy discounted gift cards, (\$50 cards for \$30), take advantage of a 50% off sale, and through the senior discount and tax exempt status, was able to get enough material for 45 blankets!

The Youth and Family Services Committee purchased window treatments for eight windows in the home housing for the first students to enter the Unaccompanied Student Initiative. An open house was held on Friday, February 26, at the home and was well attended by WCLC members. It was very rewarding to visit the home and see how these students will be sheltered and allowed to complete their education. The home is warm and inviting with each student having their own bedroom. It's truly a special place to call home!



On February 17, four members of the Committee met at the Presbyterian Church to sew pillowcases for Holly's Pillows. It took three and one-half hours to finish

the sewing project and we followed that with lunch. I want to wish a special "Thank you" to Katherine Van Dell, Phyllis Salzburg, and Mary Bracken for doing such an awesome job on the pillowcases. We had a great, fun time



together! (The committee provided pillows, pillowcases, blankets, AND Beanie Babies. Thanks to Katherine for providing the Beanie Babies...what a nice touch!)

These two projects were very rewarding on a personal level. It does the heart good to see what can be done with a little time and not much effort. There will be 15 foster children receiving their own blanket, pillow, and pillowcase to take with them wherever they go. Today, there are three students living in a home and completing their education. Once the twin homes are built this year, they will house even more students. The future holds more promise for unaccompanied students with housing planned in each school triad.

#### What is the Unaccompanied Students Initiative?

The Unaccompanied Students Initiative is a program to help unaccompanied homeless youth while not in the physical custody of a parent or guardian. These youth typically live in a variety of unsafe, temporary situations, including cars, parks, the homes of other people, shelters, and motels. The goal of the program is to provide safe and stable housing for the students, so they can graduate high school with their peers.

A residency for the students is in the works. The Unaccompanied Students Initiative is working on securing land for the house. Holy Trinity Church is helping to provide a temporary residence in the meantime. The temporary residence will house three students. The housing is free, and the only requirement is that they attend school. House parents will also live with the students. The house will get some updates, and the hope is for students to move in in January.

#### What is Holly's Pillows?

Holly's Pillows was created to give children in foster care their own pillow and blanket. CASA (court appointed special advocates) take a donated pillow and blanket to children they are advocating for. Holly's Pillows was started in Berrien County, Georgia. The CASA director there had heard an incredible story from a little girl named Holly. Holly told a story of how every house she moved to during her time in foster care smelled different. But, at night, when she buried her face in her pillow, she could smell herself, and for just a little while, she felt at peace. Can you imagine what a child must feel like when they move into foster care? All the comforts of home are gone. You now live in a stranger's house. You don't have your things. Almost everything is a reminder that you are simply not home. If you think about it, how many of us take our own pillow when we travel? Probably quite a few of us. The hope of Holly's Pillows is to give these kids a small gift to bring them comfort. Something that is just theirs. Something to bury their face in and find some peace.



## Featured Recipe

#### **Cuban Sandwich**

The Cuban sandwich, sometimes called a Cubano, is a Latin variation of a grilled ham and cheese sandwich.

Marinade:

4 cloves garlic, minced

Juice of 2 limes (about 3 Tbsp)

1/3 cup orange juice

2 tsp ground cumin

1 tsp coarse sea salt

1 tsp freshly ground pepper

1 16-oz pork tenderloin, trimmed

1 Tbsp olive oil

1 loaf of Cuban bread (Substitutes: French or Italian Bread)

Dijon or yellow mustard

1/2-3/4 lb Swiss cheese, thinly sliced (8 slices)

Kosher dill pickles, thinly sliced 1 lb cooked ham, thinly sliced

Butter

In a re-sealable plastic bag, combine garlic, lime and orange juices, cumin, salt, and pepper. Pierce pork as many times as you can with a fork, place in bag, and marinate, refrigerated, for at least 4 hours.

Preheat oven to 400° and coat an ovenproof skillet with oil. Sear the tenderloin over medium-high heat until brown on all sides. Bake uncovered for about 40 minutes (until the internal temperature reads 160°). (Turn tenderloin once, halfway through roasting, using tongs.) Remove from oven, cover with foil, and let sit for 10 minutes. Slice (thin).



The following instructions are provided for those without a Panini press: Cut the loaf of bread into half lengthwise, then slice into quarters (to make four sandwiches). Spread mustard on the bread. Then make each sandwich by layering in this order: cheese, pickles, roasted tenderloin slices, ham, and another slice of cheese. Preheat griddle or frying pan on medium heat. Lightly coat the cooking surface of the griddle or frying pan with butter. Place one sandwich onto the hot surface. Put a clean, heavy skillet on top of the sandwich to flatten it. Press the bread down to about 1/3 of its original size. Leave the skillet on top of the sandwich and grill for one to two minutes, being careful not to burn. Lift the heavy skillet, turn the sandwich over, and repeat for the other side of the sandwich. The cheese should be melted and the bread golden brown. Slice each sandwich in half diagonally and serve.

If using a Panini press: Heat Panini press. Butter each side of the press. Place the prepared sandwiches inside, press down, squishing the sandwich, and grill until the cheese is melted and the bread is flat and browned, approximately 5 minutes.

#### **Cuban Reuben**

For a taste of St. Patrick's Day!

French sandwich roll 3 slices Swiss cheese 4 slices corned beef 2 Tbsp sauerkraut

Thousand Island dressing 4 Tbsp roasted pork, shredded 1 dill pickle slice



Heat sandwich press (or Panini press). Slice roll in half, and lay two pieces side-by-side. On one half, layer a slice of Swiss cheese, 4 slices corned beef, sauerkraut, and top with ½ slice of Swiss cheese. On the other half, add dressing, then layer a slice of Swiss cheese, roasted pork, dill pickle slice, and top with ½ slice of Swiss cheese. Close the sandwich, then press down on top of the sandwich, flattening it a little. Place the sandwich in the heated press, and close the lid tightly. The sandwich is done when the cheese has melted, the meats have warmed, and the bread is crisp. Cut sandwich on the diagonal, and serve.

## Wander through Way Back

#### What tradition started 32 years ago, at the 1984 Christmas House?

Christmas House 1984 was the first year cookies were baked on-site. The Cookie Chairwomen were Dianne Kirkbride and Jean Darnes. WCLC President was Nancy Rutledge, and Bonnie Brown was the Christmas House Chairwoman. The homeowner was Paul Smith, owner of the Hitching Post Inn. Because his home was a former carriage house, the theme was "A Carriage House Christmas."

#### The Original Recipe: Christmas House Cookies



2 cups butter, margarine, lard, or shortening 4 cups flour 1 tsp soda 1 cup sugar

1 cup powdered sugar

2 eggs beaten Vanilla or almond flavoring 1 tsp cream of tartar

Dash of salt

Mix shortening, sugars, eggs, and flavoring thoroughly until light and fluffy. Stir in flour, soda, and cream of tartar, along with a dash of salt. Blend well. Chill at least 2 hours. Shape dough into a long, smooth roll 2" in diameter. If desired, roll in colored sugar, and sprinkle with candies or nuts. Wrap in waxed paper, twisting ends. Chill in refrigerator. When chilled, cut roll into ¼-inch slices; set slices about 2" apart on ungreased cookie sheet. Sprinkle with colored sugar. Bake at 325° about 8 minutes or until lightly browned on top. Let cookies sit on sheet for 1 minute, then remove to a cooling rack.

#### What was the very first year that the Christmas House was held for three days?

Same year that sugar cookies were first baked on-site: Christmas House 1984. Yes, Chairwoman Brown tried several new things that year. The House was open each day from 11 a.m. to 3 p.m. (noon to 4 p.m. on Sunday). House tour tickets were \$1.50. Horse-drawn carriage rides were given, sponsored by Bill and Chris Francis and Chevenne Frontier Days.

Recipients of Christmas House 1984 proceeds were Meals on Wheels, American Cancer Society, Grandma's Safe House, Stagehands, Goodwill Industries, YWCA, Chevenne Animal Shelter, Special Friends, Cheyenne Frontier Days (carriage restoration), the Symphony, and an East High School student (wheelchair).



#### Special Occasion Éclair Cake

Looks complicated...but take it step-by-step, and it's relatively easily to make, with tasty results!



#### Éclair crust:

1 cup water 1 stick (1/2 cup) butter 1 cup all-purpose flour 4 large eggs

#### **Cream filling:**

2 (3.4 oz) pkg instant vanilla **or** pistachio pudding mix 2½ cups milk 6 oz Cool Whip (3/4 of an 8-oz Cool Whip) 1 tsp vanilla

#### **Topping:**

11/2 squares unsweetened chocolate (1.5 oz) 2 Tbsp butter 2 Tbsp milk 1 cup powdered sugar 1 tsp vanilla

Preheat oven to 400°.

**Crust:** In a medium saucepan, melt butter in water and bring to a boil. Remove from heat and stir in 1 cup flour until ball forms. Add in eggs, one at a time, mixing thoroughly by after each. (Use a wooden spoon or a King Arthur bread dough whisk.) The pastry dough is ready when it is smooth without lumps. Drop by spoonsful into a ring on a lightly greased cookie sheet or round pizza pan. Bake at 400° 40-45 minutes or until the middle is dry. Sometimes the cake takes less time to bake; sometime more, so watch very carefully. Check with a cake tester to make sure it's done. After baking, crust should be a deep golden brown...don't remove from the oven too early (or too late)—the only tricky part of this recipe. Cool completely on a wire rack. Set aside.

**Filling:** Using an electric mixer or whisk, mix the pudding mix with milk for two minutes. Gently fold in the Cool Whip and vanilla with a rubber spatula. Cover the bottom half of the cake with filling, put the top half back on. You will have extra filling. Grab a spoon!

Carefully cut the cake into serving slices with an electric knife or serrated bread knife. (You will be piping the chocolate frosting on top, and it's much easier to cut the slices at this stage, then add the frosting.)

**Chocolate Frosting:** Melt chocolate in a saucepan over low heat. Add butter. As soon as it melts, remove from heat. Stir in milk until combined. Stir in powdered sugar and vanilla. Pack frosting in a pastry bag and pipe with a decorating tip going around the entire cake. (Or use a Ziploc bag with snipped corner). Refrigerate for a short time—until chocolate sets. Cover in plastic wrap, then return to refrigerator.

Should be served the same day it's made. However, you can prepare the three stages (crust, filling, and frosting) the day before serving, then on serving day put it all together.

Refrigerate leftovers.
